

# Wyoming Voter Registration Application Form Instructions

### Where can I register to vote?

At your local County Clerk's Office, by mail, or at the polls on Election Day.

#### What documents do I need to bring with me?

Present a valid Wyoming driver's license. If you do not have your current valid driver's license with you, you must provide the number along with additional acceptable identification as noted in the table below. To satisfy Wyoming's proof of citizenship requirement, you may use your Wyoming driver's license, provided it does not contain any indication that you are not a U.S. citizen.

## If you have not been issued a WY driver's license, or it is expired, you must provide:

- ✓ A statement to that effect;
- ✓ The last four digits of your social security number;
- ✓ Proof of identity;
- ✓ Proof of citizenship as noted in the table below; and
- ✓ Proof of residency as noted in the table below.

If you have neither a valid Wyoming driver's license nor a social security number, please indicate this by checking the appropriate box on the Voter Registration Application form and contact your County Clerk.

### What do I need if I decide to mail in the application?

If you are mailing the voter registration application in, you will need:

- ✓ To complete the form and sign the oath before an oath-taking officer;
- ✓ To include a (scanned) paper copy of the identification shown to the oath-taking officer; and
- ✓ Mail the form and printed copy of your identification directly to your local County Clerk's office.

### What if I have committed a felony?

In accordance with 7-13-105, persons who are first time, nonviolent felons may be issued a restoration of voting rights certificate after completion of sentence or probation. Contact the Wyoming Department of Corrections for further details. It is advised to bring your restoration of rights certificate issued by the State of Wyoming when registering to vote.

### What are the deadlines to register?

Voter registration closes two weeks prior to an election. You may, however, still register and vote absentee simultaneously within that two week period or at the polls on Election Day.
