The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and began at 1:30pm. Byron Mathews began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Byron asked if there were any requests for changes or corrections to the minutes. Chief Kopper made a motion to accept the minutes as written. Tracy Garcia seconded the motion. All board members voted in favor.

2. Finances

Carrie Deselms provided the finance report. Carrie stated that the normal expenses were paid for the month. She stated that the bill for the Executive Meeting lunch which will be reflected on next month's report was paid. Jeanine West motioned to approve the financial report. Tracy Garcia seconded the motion; all board members voted in favor.

3. Monthly Reports

- a. Narva & Associates: Jon Narva reported that the report reflects a typical month. He reported that the change was made to where Suburban was made a "Level of Effort" response. Jon included the numbers in the report to still reflect how AMR is doing in that area. This month also didn't take into account the calls that were changed from Suburban to Urban without any exemptions to see statistically how AMR was doing in that area as well. They were still on time in this respect. There were no recommendations, but there were a couple observations to report. There was one call that Kassi reported to Jon and was discussed with Cheyenne Fire Rescue. A Priority 2 call had a response time of 1hr and 5 min during a surge timeframe. Due to its level, the call continued to be moved for higher priority calls. Conversations between the agencies involved took place to resolve tying up other resources in this type of situation. There has been some resolution, but there were no negative outcomes from this situation.
- b. AMR: Cody Schilling provided the report for AMR. He reported that the total calls and transports were up from October. Cody also stated that AMR was compliant in all zones and priorities. There was 7 extended delay for the month of November. Cody also reported that the core schedule does have some changes that will be starting with the new contract. He stated that they are fully staffed on EMTs and on paramedics. They are still seeking part-time Paramedics and EMTs. Under preventative maintenance they have checked to make sure that the 4WD on the units are ready. Their new Type I has been sent back to Texas for warranty work. He added that MS158 is out for service to resolve some additional issues. With the DriveCam there were 56 events triggered. The triggers caused by speeding were due to the speedometer issue, but a replacement unit has been provided which should decrease that number. All triggers were coached. Cody stated that there were 4 clinical reviews and they reviewed 233 charts and all 13 cardiac arrest cases were reviewed by the Education Chief Larry Jones. AMR also reviewed 256 runs, but that due to recategorizing of charts the number is higher. Cody continued with his report that several trainings were done over the month including CPR classes for LCCCC. He added that the Comm Plan trial was ended due to several issues and will revisit it at the beginning of the year. AMR had several mutual aid requests that they responded to and they continue to do mobile health. He stated that AMR participated in a few events during November. Cody ended his report by stating that they are working on auto launch policies with LifeLine 3 to better serve all of Laramie County. They are also working with them to ensure all LifeLine equipment is secured during ground transports. Kassi wanted to add that concerning the extended delay call that Jon reported on, she did have a meeting with LCFD #1 and CFR regarding the use of MS343. They are still working on the SOP with LCFD #1 but that if CFR is the requesting MS343 they will continue on route and will transport the patient.

4. Medical Directors

Nothing to report.

5. CRMC

It was announced that this meeting would be Tracy Garcia's last meeting and that Sarah White has been appointed as the CRMC rep for the EMS board. Sarah White introduced herself to the group. The question was asked about the garage doors to the ED and if they were still having issues. Sarah said that she will look into the status of the doors.

6. LifeLine

Jenn Kerr reported that they are working on securing the equipment in the AMR units.

7. LCCCC

Amber Young thanked AMR for the CPR trainings. She reported that there was a meeting to discuss alternatives to ProQA.

8. <u>Eastern Laramie County</u>

It was announced that this meeting was Carrie's last meeting with the Board. She reported that Jill Vaudrin has been appointed as the supervisor for the Burns EMS. Carrie added that Pine Bluffs has been busy over this past month with calls. Everyone thanked Carrie for her service on the Board.

9. FE Warren AFB

Nothing to report.

10. <u>VA</u>

Nothing to report.

11. Cheyenne Fire Rescue

Chief Kopper reported that they have 4 graduated recruits now working the line. They are looking to begin bidding on the fleet and stations to be built. Brice reported that they now have 2 Paramedics that will begin their shifts. He added that they will continue working on the ALCO project.

12. County Fire Districts

Nothing to report.

13. County IT

Nothing to report.

14. Funding Requests

No funding requests were received.

15. Old Business

a. RFP for Contract Administrator: It was reported that the Board received 1 bid which was from Narva & Associates, Inc. Jeanine West made a motion to approve the bid and move forward with negotiations to include discussion on insurance requirements. Jon commented that the current contract requirements are difficult to meet due to the insurance companies lack of offering that category. Jeanine responded that she would

- need the information on what is available so that she can confer with the County Attorney. Carrie Deselms seconded the motion. All voted in favor.
- b. Board Member Application: Byron reported that they had received 3 applications by the deadline and the Board will move forward with interviews.

16. New Business

a. Contract Billing Compliance: Kassi brought up for discussion on the MAB concerning the wheelchair rates. They found that these rates had been inadvertently left out of the contract and Kassi was requesting what the preference of the Board would be to account for these rates. Byron requested that information be sent to the Board and Jon so that it can be discussed and determine a course of action. Kassi presented the new table in Exhibit 3 to the group. She pointed out that the wheelchair rates were included in the old contract. Jeanine recommended that the new table be sent to the Board so that they can vote to amend the Exhibit 3 with the new rates. Jeanine West made a motion to approve the update to Exhibit 3 and replace the new rates in the contract. Jon pointed out to the Board that per the contract, a Public Hearing will be held prior to approval of this exhibit. Byron summarized that we will need to have a Public Hearing at the next regularly scheduled meeting to approve the new rates. Beth clarified that a Public Notice will need to be submitted to the newspaper and posted on the website for the January 11th meeting. The motion did not carry for lack of a second. Jeanine West made a motion to approve the amendment pending the Public Hearing at the January 11th meeting. Carrie Deselms seconded the motion. All members voted in favor.

The meeting was adjourned at 2:00pm.
