The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person at the Cheyenne/Laramie County EMA beginning at 1:32pm. Jeanine West began the meeting by welcoming everyone.

1. CFR Appointment Letter

Jeanine West announced that Byron Mathews was appointed the new State Fire Marshal and that Titus Norris, Battalion Chief, with Cheyenne Fire Rescue had been appointed as the new representative for the Board per a letter received by Mayor Collins.

2. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Josh Van Vlack made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

3. Finances

Chief Kopper reviewed the financials for the month which were typical for the month. Josh Van Vlack made a motion to accept the financial report. Jared Skagen seconded the motion. All board members voted in favor.

4. Monthly Reports

- a. Narva & Associates: Jon Narva was unable to attend the meeting. Jeanine West briefly reviewed the Narva & Associates report and noted that the group can review the report and contact Jon with any questions. AMR was compliant for the month and had 3 extended delays.
- b. AMR: Kassi Moloney reviewed the AMR monthly report with the group which was sent out prior to the meeting. Kassi reported that there was an accident with one of the units this past month where the ambulance was deemed a total loss. All of the crew and the patient were fine with minor injuries and the patient was taken back to the original destination. The accident is still be investigated by Wyoming Highway Patrol. She made a note that AMR had developed a new Risk Assessment form for long distance transports after the recent accident and received input from other areas on what they use. The group discussed the report form.
 - i. Rate Increase Presentation: Kassi provided a presentation on the rate increase that was submitted earlier. She reviewed the figures that were provided in the presentation which led to a proposed rate increase of 19.1% to be implemented upon approval. The rest of slides were supporting documentation for the rate increase. Jeanine reviewed that the Board has 15 days to respond to the rate increase request. Chief Kopper suggested that the Board be given time to review the proposal. Kassi asked for clarification that the approval must be during a public meeting. Jeanine affirmed the statement and the contract would need to be amended if approval was given. Kassi asked if there was anything that AMR could present to the Board to clarify the request. There was discussion amongst the group about the reasoning for the request and the data presented. Jeanine recommended that if the members of the Board has any questions that they be given to Jeanine by the end of next week so that they could have an Executive Session prior to the next meeting.

5. Medical Directors

Dr. Schmitz reported that the Albin EMS meeting went well but the road conditions in the area were difficult due to recent weather events. During the meeting they reviewed patient care for the recent US 85 accident. He added that the Pine Bluffs EMS meeting went well and they reviewed their runs. Pine Bluffs EMS is planning for PIT crew training and looking at having an on-call rotation. Dr. Schmitz noted that they are considering changes to protocols that will be discussed at the next protocol committee meeting. He is also working on his DEA registration for Cheyenne Fire Rescue. Dr. Tortorich reported that case reviews went well, but additional conversations need to take place about having in-person meetings again for case reviews. She added that there is discussion about looking at a better way to get follow-up with EMS crews and access to EPIC. Jared Skagen stated that he would ask CRMC about this option.

6. CRMC

Jared reported that due to construction on 24th St. arrivals to the hospital will be interrupted and also the helipad was open again.

7. LifeLine

Nothing to report.

8. <u>Dispatch</u>

Amber Young reported that they had 11675 calls for service with 1256 of them being EMS calls. Amber stated that they are currently at 50% staffing due to staff leaving for various opportunities. She announced that Telecommunicators Week was April 9-15 and the awards banquet would be April 13th.

9. Eastern LC EMS

Tony Perry sent Jeanine a report. Jeanine reported that much of the report was covered by Dr. Schmitz, they are looking at doing a skills practice session when the weather improves. He added that LCFD #6 had reached out to him to help with additional training. They did receive a grant for 7 new LifePacks and AEDs.

10. FE Warren AFB/VA Medical Center

Dr. Berg reported they are working with the VA to finalize training.

11. Cheyenne Fire Rescue

Chief Kopper wanted to thank Byron Mathews for years of service with the department and welcome Titus Norris to the Board. He added that there are 2 new Fire Fighters. Brice Jacobsen stated that they will be working through the attendance issues with case reviews.

12. County Fire Districts

Josh Van Vlack stated that Laramie County Fire Authority had asked if there could be additional communications to the fire districts about any status changes with CRMC. Amber replied that LCCCC could help with that but she would need communications from CRMC. The group discussed solutions for communicating changes to the count fire districts. It was decided that Matt Butler would reach out to Candis Pickard about being put on the contact list for notifications and that he would forward the information to the districts.

13. <u>Information Technology</u>

Nothing to report.

14. Funding Requests

No funding requests were received.

15. Old Business

a. Medical Director Contract: Jeanine announced that Dr. Schmitz had been awarded the Medical Director contract starting March 1st, 2023. The Board presented Dr. Tortorich with a plaque for her years of service as the Co-Medical Director for Laramie County.

16. New Business

- a. Protocol App Survey: Jeanine announced that the survey for input about the current protocol app was sent out. Beth Harris provided a review of the survey results in which 11 responses were received. The Board discussed that the lack of responses were a concern and suggested that the survey be sent out again to the various agencies that use the app. Beth will send the survey out again to the group for their responses.
- b. Elections: Jeanine stated that due to Byron Mathews departure from CFR and the Board, that the Vice-Chair position was vacant. Chief Kopper nominated Josh Van Vlack for the position. Jared Skagen seconded the motion. All voted in favor.

In response to the AMR proposal for a rate increase, Chief Kopper made a motion to move into Executive Session. Jared Skagen seconded the motion. The Board moved into Executive Session at 2:35pm. The Board returned from Executive Session and continued the meeting at 3:19pm.

c. AMR Rate Increase: Jeanine reconvened the meeting and thanked everyone for their patience. After discussion and review of the proposal Josh Van Vlack made a motion to offer a 7% contract adjustment each year for the next 3 years as long as AMR remains in compliance under Contract Section 6.24. Jared Skagen seconded the motion. All voted in favor. Jeanine stated that a letter would be sent within 15 days of the meeting to AMR and if they had any questions to contact the Board.

The meeting was adjourned at 3:21pm.


