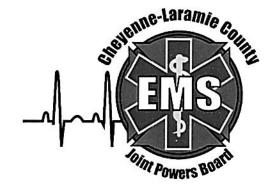

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and virtually via Zoom and began at 1:30pm. Byron Mathews began the meeting by welcoming everyone.

1. Introductions

Byron announced that 2 new members were appointed to the Board and allowed them to introduce themselves. Josh VanVlack was the first for introductions. He is a Division Chief for LCFA, his regular occupation is with State Forestry and has an extensive background in fire. Belit Tolluoglu continued with his introduction. He is now the representative to the Board for CRMC. He oversees the ED at CRMC and has many years in the nursing field. Those in attendance provided introductions to the new Board members.

2. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Byron asked if there were any requests for changes or corrections to the minutes. Jeanine West made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

2. Finances

Beth Harris provided the finance report. Beth stated that the normal expenses were paid for the month. She stated that the bill for the annual Medical Director 1099 tax paperwork through Yearli was paid. She added that the annual Equipment Reserve payment for \$15,000 was received from AMR. Chief Kopper motioned to approve the financial report. Jeanine West seconded the motion; all board members voted in favor. Byron asked about steps that need to be taken after elections. Beth responded that she has all the paperwork and will be in contact with whomever is elected to get the bank documents updated.

4. Monthly Reports

- a. Narva & Associates: Jon Narva announced that he changed the format of the monthly report to coincide with the new EMS map layer changes. He reported that the largest percentage of calls were in the Urban zone and all calls were further broken down in the report by geographic zone and priority. Jon stated that they were compliant in all areas. Total calls for service over the month were 1124. Jon introduced a new section to the report, Monthly Efficiency & Effectiveness. This section discusses the utilization of the AMR units. Under observations, Jon noted that there were 9 delayed responses during the month which were summarized in the report sent out to the Board. Of the 9 delayed response, only 1 Priority-1 was delayed. They were 90% compliant in all zones and priorities. There was a system issue earlier in the month with CAD to OPAP and Imagetrend interfaces, but this issue did not cause an issue with response capabilities or data. The group had a discussion on the new zones for the EMS map layer. Jon asked the Board for clarification concerning Section 11.4.3 of the contract and assessing liquidated damages for extended delay calls. He commented that it was his interpretation that since AMR was still compliant for the month, that the individual calls that were extended would not have liquidated damages assessed. Byron stated that it was his understanding that Jon would be correct. The Board members involved with the contract development agreed that was the interpretation. Jeanine wanted to verify that everyone had received the Exhibit 3 update.
- b. AMR: Kassi Moloney reported that they had 9 calls for mutual aid, 2 in Weld County and 7 in Albany County. The number of units available and how that affects Mutual Aid calls was discussed by the group. Byron stated that if the system is already at the limit for units available, then unfortunately the Mutual Aid response would be denied. Kassi added that the system status threshold was updated to 2 with LCCCC. Kassi continued to review the report sections with the group. She noted that they currently have 2 students enrolled in the "Earn as You Learn" program. Kassi announced that the MOU with the LCCCC was updated and signed this past month in addition to updating policies with LCCCC to reflect the changes made in the contract. Kassi addressed complaints received from CFR personnel, they were resolved and addressed.

There were 2 clinical investigations completed this month and several chart reviews were complete. Kassi reported that they are continuing to work on the CAAS accreditation and are on schedule to complete the application. Beth wanted to thank Larry Jones and Haileigh Jefferson for helping with the CERT training. They did an excellent job teaching the medical sections and asked that Kassi pass along their appreciation.

Medical Directors

Byron stated that he had a discussion with Dr. Schmitz. He reported that there has been changes with the ambulance services. Commissioner Heath announced that Burns EMS had been shut down. Jeanine added that LCFD #4 will be using the ambulance for training purposes, but will not be running an ambulance service. Commissioner Heath reported that the equipment will be donated to LCFD #4. It is still unclear at this time where the ambulance will actually be housed. Byron commented that regardless of the status, AMR has been providing service to these and other areas outside of Cheyenne at an exceptional level and they will continue to do so.

6. CRMC

Bellit reported that they are experiencing staffing shortages and therefore CRMC has been utilizing traveling nurses to fill in where needed. He added that the flooring is almost completed. CRMC is also making changes to the desk intake window.

7. LifeLine

Jenn Kerr reported that LifeLine has officially been in the area for a year and this past month handed out special awards to employees. She stated that LifeLine 19 was in service and they are open to outside agencies for training purposes.

8. LCCCC

Amber Young wanted to say thank you to AMR for their work on getting the MOU completed. She added that they had 1315 EMS calls through LCCCC and are working on the CAAS accreditation.

9. Pine Bluffs/Burns/Albin EMS

There was nothing further to report.

10. FE Warren AFB/VA

Nothing to report.

11. Cheyenne Fire Rescue

Chief Kopper reported that they had 2 Paramedics finishing their training at LCCC and they now have 40 Paramedics. He added that they have ordered 3 engines and 1 ladder truck. They are also working on the plans for the new fire stations that were recently approved and will be looking at hiring 9 new fire fighters. Brice Jacobsen reported that there has been a delay with implementing the ALTO project due to contracts and therefore the start date has been moved to April 1st. He added that CRMC had requested ARPA funding for the ALTO training.

12. County Fire Districts

Matt Butler wanted thank AMR and LCCCC for their assistance this morning with a significant response which was successful.

13. <u>Information Technology</u>

Nothing to report.

14. Funding Requests

No funding requests had been received.

15. Old Business

a. Board Elections: Byron began by opening the floor for a selection of officers for the Board. Jeanine West volunteered for Chair. Chief Kopper made a motion for Jeanine to take the roll of Chair, Byron Mathews as Vice-Chair and himself as Secretary/Treasurer. Josh VanVlack seconded the motion. All voted in favor of the election of these officers.

16. New Business

a. Snow Cat: Jeanine announced that yesterday EMA received their Snow Cat and invited everyone to take a look. The vehicle picked has the capability of hauling a cot in the back seat. Training will be provided by Larimer County in the future.

The meeting was adjourned at 2:27pm.
