

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person at the Cheyenne/Laramie County EMA beginning at 1:32pm. Jeanine West began the meeting by welcoming everyone.

#### 1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Chief Kopper made a motion to accept the minutes as written. Josh Van Vlack seconded the motion. All board members voted in favor.

#### 2. Finances

Chief Kopper reviewed the financials for the month which were typical for the month. Chief Kopper noted there was a debit card error during the month, but it was resolved. Josh Van Vlack made a motion to accept the financial report. Jared Skagen seconded the motion. All board members voted in favor.

#### 3. Monthly Reports

- a. Narva & Associates: Jon Narva provided his report via conference phone. He reported that AMR was compliant in all areas and priorities for the month. There were 979 calls for service which was an average of 35 per day. There were 59 exemption requests, 0 were denied, and only one weather exemption period. Jon noted that there were 6 extended delays which were all Priority 5 transfers that were put on hold for higher priority calls. Jon stated that the EMS Certification letters had been sent out with quite a few responses already. He added the deadline for submission is March 31<sup>st</sup>.
- b. AMR: Kassi Moloney provided her report to the group. There were 5 mutual aid responses for the month and she reviewed the delays by priority. The schedule has not changed but the bid for the schedule beginning May 1<sup>st</sup> will begin this month. Kassi reviewed the staffing for AMR. She continued with her report listing the special events and training. There was 1 clinical investigation completed for the month. They conducted 150 chart reviews which low due to staffing. It was reported that there were 34 total events and preventative maintenance was completed. Kassi stated that they are conducting their annual SOP review per CAAS standards and the Exhibit 2 is also being reviewed.

#### 4. Medical Directors

Dr. Gary Schmitz provided his reports for the meetings with EMS providers. For Albin they discussed Hypothermia and frost bite. He is meeting with Pine Bluffs on Thursday night to conduct a cardiac arrest training with them. Dr. Schmitz reported that at the AMR meeting, they discussed a medic issue which has been resolved. They talked about additional educational opportunities and attending more national EMS meetings. He also mentioned that Laramie County Fire District #6 has licensed EMTs and will meet with them to discuss medical response and review their equipment. He added that he is working with the state to revisit a statewide trauma system and will start conducting reviews for all hospitals in the state. Jeanine mentioned that due to a situation this past month, CLCEMA had ordered shelter supply kits for Albin and Burns in case a shelter needs to be setup in these rural areas.

#### 5. CRMC

Jared provided an update that for patient follow-ups, they need to go through either Medical Direction or Jared.

#### 6. LifeLine

Jenn Kerr was pleased to have the fire chiefs on the email list for notification of when the helipad is closed.

#### 7. Dispatch

Amber Young reported that they had 11219 calls for service with 1147 of them as EMS calls. She noted that they are at 50% staffing and they are taking applications. There is a hiring bonus now. The awards dinner is April 13<sup>th</sup>.

#### 8. Eastern LC EMS

Jeanine reported for Pine Bluffs. She said that there were no updates for the group.

#### 9. FE Warren AFB/VA Medical Center

Jeanine provided the report for FE Warren. She noted that the clinic will be conducting an exercise with the VA.

#### 10. Cheyenne Fire Rescue

Chief Kopper reported that they are working on the budget, MOUs and contracts. He added that they have made 8 conditional offers for employment using the SAFER grant funding. Chief Kopper also announced that there will be a retirement celebration for Byron Mathews tomorrow.

#### 11. County Fire Districts

Josh Van Vlack reported that LCFA is halfway through one of their trainings. He announced that ESO purchased Emergency Reporting and they will be ending Emergency Reporting. State Forestry, Office of EMS and State Fire Marshal are working with ESO to find an allencompassing reporting system that would include EMS calls for the state.

#### 12. Information Technology

Nothing to report.

#### 13. <u>Funding Requests</u>

Nothing to report.

#### 14. Old Business

a. AMR Rate Increase: Jeanine reviewed that at the last meeting the Board approved a 7% rate increase over 3 years and AMR accepted the proposal. She stated that the resolution still needs to be reviewed by legal before getting signatures. It is estimated that the approved resolution will be completed by next month's meeting. A copy of the resolution was provided to AMR to review.

#### 15. New Business

a. Protocol App Survey: Beth Harris provided an update for the survey that there were 25 responses received, but the due date is April 3<sup>rd</sup>. She encouraged everyone to resend the link to the survey if there is anyone that has not yet completed it.

The meeting was adjourned at 2:03pm.
