The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and virtually via Zoom and began at 1:31pm. Jeanine West began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Josh Van Vlack made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

2. Finances

Chief Kopper reported that he had completed the signature paperwork for the new account, otherwise there was nothing else to report on the finances. Beth Harris stated that the Board received a tax form in the mail and it has been forwarded to County Finance to determine

if any further action is needed. Josh Van Vlack motioned to approve the financial report. Byron Mathews seconded the motion; all board members voted in favor.

3. Monthly Reports

- a. Narva & Associates: Jon Narva reported that there were 41 exemptions requested during the month with 1 exemption being a blanket period. There were 920 calls for service for the month. There is a reduction due to the short month but fully compliant in all areas. The new map layer worked well. In the Monthly Efficiency and Effectiveness of the report, the numbers did show a decrease in business but further investigation as to why would need to be conducted outside of it being a short month. The extended responses were for lower priority calls which were moved due to higher priority calls. There was nothing out of the ordinary to report and AMR was compliant in all areas. Jon stated that the EMS certification letters were sent out and only 2 organizations have returned their certifications. Jon recommended that a reminder email be sent out to the remaining organizations in about a week. Jeanine stated that she could send out a reminder. An announcement would also be made during the Fire Chiefs Association meeting on Wednesday.
- b. AMR: Kassi Moloney reported that they had a decrease in calls for the month, but overall it was a standard month. There were 5 calls for mutual aid, 2 in Weld County 2 in Larimer and 1 in Kimball County. Kassi continued to review the report sections with the group. She stated that they have one extra EMT and are still short 1 full time Paramedic. She noted that they currently have 2 students finishing their Paramedic program. Kassi added that they are still doing Mobile Health for Holly Frontier and they are in the process of talking with them about the program moving forward since they no longer have a nurse onsite. She reported that events were lower this time of year and she reviewed the list of events they participated in and are planning for. Kassi reviewed the report for their activity with partner agencies. An incident report was received from CFR and they are currently working on the investigation and resolution of the issue. She added that there was 1 open clinical investigation and chart reviews were conducted. Kassi stated that several trainings were conducted over the past month. She finished her report by talking about the DriveCam report and maintenance that was conducted on the units. Kassi updated the group on the CAAS accreditation and that they are on schedule to complete the application by March 31st.

4. Medical Directors

a. COVID Protocols: Jeanine provided an update on the COVID situation. The state is closing down the response. There was a question about the protocols that were placed and revisiting a discussion when it started about developing pandemic/infectious disease protocols based on the COVID response. Brice Jacobsen commented that the protocol would be added in pandemic terms and look at removing it in April. The Protocol Committee would look at it later in the year. There was further discussion amongst the group on the past discussions when it was originally implemented. It was suggested that it be discussed with CRMC, AMR, Jon Narva, the Medical Directors and Brice Jacobsen. As for the EIDS tool, this would be discussed among the Fire Chiefs to determine if it was still needed.

5. CRMC

Bellit reported that COVID numbers are down and the garage doors in the ED are broken again. Jeanine announced to the group that the agreement between the VA and CRMC will not be renewed once it is expired.

6. LifeLine

Jenn Kerr reported that LifeLine will have a nurse position open in the summer. She added that they will be doing a joint commercial with CRMC on the stroke program.

7. LCCCC

Nothing to report.

8. Pine Bluffs/Burns/Albin EMS

Jeanine reported that Chief Walls is stepping down as the Pine Bluffs EMS supervisor but will respond if needed. At this time a replacement has not been appointed. It was noted that there was a call over the past month that would need a joint review between Pine Bluffs EMS, AMR and Lifeline. It did not concern patient care.

9. FE Warren AFB/VA

Major Wetzler reported that COVID numbers are down and the Department of Defense has begun to relax their rules.

10. Chevenne Fire Rescue

Chief Kopper reported that he received an email that the Granit Rehab elevators were not working. Brice announced that they are working with AMR on integrating their reports to allow for more information from the actual call to be available to the doctors.

11. County Fire Districts

Nothing to report.

12. Information Technology

Nothing to report.

13. Funding Requests

a. ALTO Project: The request was submitted by Brice Jacobsen on behalf of CRMC. Brice explained the project and its purpose. This would be a system enhancement in that all EMS would benefit with the program. Jeanine asked if the national group conducts a Train-the-Trainer or if it was an annual update to the program. Brice stated that the video listed in the funding request would be part of the training program and not need to be redone annually. This would be a tool for the TTT portion of the program. He added that this part of the program was just to get our program started and CRMC would not need any additional funding in the future. Jeanine asked Brice that since the funding request was through Cheyenne Fire Rescue, would the Board be submitting payment to them or to CRMC. Brice stated that it should be paid to CRMC since the original contract is with them. Byron

asked who was funding the initial amount and Beth clarified that there was a discrepancy in the description on the Funding Request and the actual amount being requested. Brice responded that the correct overall total for the program was the sum stated on the spreadsheet, not what was in the description. Jeanine asked who the contact person was for CRMC and Brice stated that it was Angela Vaughn. The group discussed the overall management of the program and training. It was pointed out that this would not be a regular request for funding in the future, but a onetime payment for the program. It would be the responsibility of CRMC to sustain the program. The group also discussed the benefits of the program to our community. Chief Kopper made a motion to approve the request for not to exceed \$12,514. Josh Van Vlack seconded the motion. During discussion, Byron asked what the benefit is of the ALTO program, how is improvement documented. Jeanine asked if there was any reporting that the Board could request to see the progress of the program. Brice stated that Angela Vaughn will be compiling the data for the program and sharing the information with their partners. Josh asked for a point of clarification on the motion and that the motion should state that the funding would be paid to CRMC. Chief Kopper amended the motion to include that payment would be made to CRMC. Josh Van Vlack seconded the motion. All members voted in favor. Beth addressed the Board that since this funding was not reported in the regular budget that an amended budget must be submitted to the state. Byron Mathews made a motion to amend the budget to reflect the approved motion to satisfy the reporting requirements for the State of Wyoming Department of Audit. Chief Kopper seconded the motion. All members voted in favor. Jeanine asked Brice to send Angela Vaughn's contact information to Beth.

b. Albin EMS: Jeanine reported to the group that a funding request from Albin EMS had been submitted later today and after review it was incomplete. The request was for batteries for their Stryker unit and the Optivac G180 Suction Pump which are currently not functional on their ambulance. Byron Mathews moved to deny the request due to incomplete application. Josh Van Vlack seconded the motion. All members voted in favor. Kassi stated that AMR would be willing to work with Albin EMS to order supplies through them. Jon commented that since Albin has challenges with their equipment that perhaps someone would be able to assist or loan spare equipment to Albin EMS. Jeanine recommended that LCFD #4 could be contacted to determine if the old Burns EMS equipment could be loaned to Albin in the meantime.

14. Old Business

There was no old business to discuss.

15. New Business

There was no new business to discuss.

The meeting was adjourned at 2:33pm.
