The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and virtually via Zoom and began at 1:31pm. Byron Mathews began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Byron asked if there were any requests for changes or corrections to the minutes. Josh Van Vlack made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

2. Finances

Byron reported that the payment to CRMC for the ALTO project was done and that the amended budget was submitted to the state. Chief Kopper added that the payments were

typical with an annual payment for Quickbooks subscription and that the Board was waiting for the state's response to the amended budget. Belit Tolluoglu motioned to approve the financial report. Josh Van Vlack seconded the motion; all board members voted in favor.

3. Monthly Reports

- a. Narva & Associates: Jon Narva reported that AMR was compliant. There was a Priority 4 call for a scheduled transfer that was determined to be late. Due to a lack of there being 100 calls, it could not be analyzed. After a brief discussion with AMR, the call should have been coded a Priority 5 call. There were 5 total delayed responses for the month out of 934 calls. Jon stated that there was nothing out of the ordinary for the report.
 - i. EMS Response Map Layer: Jon reported that he has been working with County GIS and presented a graphic of the map to the group. It was noted that Burns EMS needs to be removed from the map. There is another map that is not as detailed. Jon stated that this map needs to be added to the contract under Exhibit 7. Byron agreed that it needs to be added and recommended that both maps be included. Chief Kopper made a motion to add the Exhibit 7 to the contract that consists of the 2 EMS Response Map Layer maps presented. All voted in favor. Later in the meeting Byron did acknowledge that before the map layer is added to the contract, Burns EMS needs to be removed from the map. No one objected to the change.
 - ii. Protocol Committee: Jon reported that they had met before the meeting with the medical directors present. They updated 5 protocols but tabled 2 of the changes. He added that there were no major changes just adjustments to medication levels. They will be signed off soon and send to the Board when completed. The 2 that were tabled involved clarification on multi-traumas involving head and the ALTO protocol due to training. The ALTO training will be sent to the Board which will be forwarded to the responding personnel.
- b. AMR: Kassi Moloney reported that they had a decrease in calls for the month. She noted that the call numbers were down in all priorities and inquired if anyone else was seeing the same thing. Kassi continued to review her monthly report beginning with the transport numbers. She added that with staffing challenges and contract requirements they have added a third Captain and moving back to 24 hour shifts. Kassi reported that they are starting to plan for upcoming events. Kassi reviewed the report for their activity with partner agencies. She noted that one of the elevators at Granite Rehab Center is working. She stated that there were no open clinical investigations and chart reviews were conducted. Kassi stated that several trainings were conducted over the past month. She finished her report by talking about the DriveCam report and preventative maintenance that was conducted on the units. Kassi updated the group on the CAAS accreditation and that they are on schedule to complete the application by May 1st.

4. Medical Directors

Byron provided a report from Dr. Schmitz. He worked with the Albin EMS group on various topics. Dr. Schmitz stated that there some challenges between LCFD #3 and Albin EMS concerning certifications. It was stated that LCFD#3 is registered with the state as a non-transport advanced EMS system. Byron asked if Jon had received anything from LCFD #3. Jon replied that he had not and was in contact with Dr. Schmitz concerning this issue. Byron commented that Dr. Schmitz had encouraged them to change to a basic EMS system but they still have to meet the Board requirements in order to continue operating under the Medical Directors for the Board. Jon added that the history of the system was that the ambulance was going to be shut down and the current certified responders would move to LCFD #3 to make it a fire rescue. It was then decided that the ambulance would continue to operate and since then there has been some confusion when it comes to response protocols. Jon did note that all certifications had been received from LCFD #3 and Albin EMS.

CRMC

Bellit reported that numbers are down and the garage doors in the ED are broken but they are working on fixing them. He added that they hired a new director for trauma and ED. Belit addressed the ALTO funding and the question from last meeting about future funding of the program. He stated that he had discussed it with Angela and they will not be requesting further funding from the Board. She is looking at other sources of funding for the future.

6. LifeLine

Jenn Kerr reported that LifeLine will have a meet and greet with the fixed wing on April 27th. Everyone interested is welcome to come.

7. LCCCC

Byron, on behalf of the Board, wanted to say thank you to LCCCC in recognition of Telecommunicators Week. Amber provided a report on calls for service and the center is staffed with personnel working 8 hour shifts instead of 12 hour. She added that they will be having an open house on April 13th and invited everyone interested to attend from 8am to 8pm.
