The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and virtually via Zoom beginning at 1:34pm. Jeanine West began the meeting by welcoming everyone.

1. CRMC Board Representative

Jeanine introduced the new CRMC Board Representative, Jared Skagen, to the group. Introductions by those present were made and the group welcomed Jared to the Board.

2. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Chief Kopper made a motion to accept the minutes as written. Josh Van Vlack seconded the motion. All board members voted in favor.

Finances

Chief Kopper reproted that the payments were typical for the month. Beth Harris reported that nothing further was heard on the amended budget. She added that the annual budget is due and a copy of the proposed budget was sent to the Board. Beth stated that the budget will need to be approved at the June meeting which will be a public meeting. The legal notice would be sent out this week and posted in the Wyoming Tribune Eagle and on our website. Jeanine added that the public meeting will be held at the beginning of next month's meeting followed by the regular monthly meeting. Byron Mathews motioned to approve the financial report. Josh Van Vlack seconded the motion; all board members voted in favor.

4. Monthly Reports

- a. Narva & Associates: Jon Narva reported that overall it was a normal month and AMR was compliant in all priorities. He stated that there was a followup on the new graphic for the EMS Response Map Layer. He reported that he did followup with Jeff Kling in GIS and they are working on it. The correction to the map was to remove the Burns EMS wording, but otherwise the response map is working with the system and there have not been any issues. There were 43 exemption requests with 2 denials for overload requests. Jon reviewed the definition of an overload. He explained that one denial did not meet the requirements for it to exempted, but the other was denied due to some confusing wording in the contract. There will be further discussion on the wording later in the agenda. Jon reported that there was one issue that AMR is working on with their OPAP representatives to resolve calculations. The OPAP report showed 4 late calls for transports and AMR noted that there were actually 6 late calls. The data is valid and correct. Jon added that OPAP does calculate Priorities 7-9 even though they are not part of the contract and therefore he did include it in the report for the Board to review. Jon reported that the total unit hours are consistent with the contract and overall calls were up for the month. Under recommendations, Jon recommended the approval of the Exhibit 2 changes. He also recommended that the Board discuss and correct the wording in the contract relating to the overload calculations under 11.3.3.c to 11.3.3.e. The exemption to Priority 1 & 2 should be moved from the overload section to the 100 Call Rule.
 - Exhibit 2: Jon reported that he was able to confer with the Medical Directors on the changes to the exhibit. He reported that they were approved and AMR was notified that the changes could be made.
- b. AMR: Cody Schilling reported on the number of calls and the late calls that were reported for the month. There were 10 mutual aid responses in the surrounding areas. Cody reviewed the various call types for the month. He added that the schedule remain unchanged, however a new schedule will begin May 2nd to coincide with the CFR

schedule. The new schedule for the entire system will begin May 16th, but there are minimal changes to this schedule. Cody stated that for staffing they are down 3 full time EMTs and 2 full time Paramedics but they will be hiring people over the next month. He continued stating that they are still on call for Mobile Health and reviewed the many special events they participated over the month. Cody reviewed the many activities with their partner agencies and upcoming events for the season. He announced to the group that there was a change in the posting locations from Blue FCU to the VA. There were 3 clinical investigations completed and chart reviews were conducted. Cody reported that several training classes were conducted and preventative maintenance was completed. He noted that MS158 had an issue with overheating and that it was being repaired. Cody stated that there were DriveCam triggers which included hard breaking, speeding due to some units not being able to be governed, and close proximity. He announced that the CAAS application was submitted and they will be starting a new Therapy Dog Program. AMR has found a dog, but they need to hire a handler.

5. Medical Directors

Dr. Tortorich reported that there some questions on expired medications and participated in the ALTO training. They are looking at the protocol for ALTO. There will be a special protocol meeting for the ALTO protocol on Thursday.

6. CRMC

Jared Skagen reported that the garage doors are still not working and that unfortunately there is no time frame for the repairs. The hospital has now implemented a badge access system due to unauthorized persons entering the ED. He acknowledged that there have been some challenges with the badging for AMR personnel and discussions are being had between Security and AMR. Jared announce that the helipad exercise will be May 24th. Jeanine asked if the badge requirements were in response to the CMS requirements. Jared stated that it was not a specific CMS requirement. Jeanine also asked how the CRMC transports were going. Jared replied that this past month they had 790 transports.

7. LifeLine

Jenn reported that they are scheduled to conduct training with AMR and if anyone is interested they are welcome to attend the Landing Zone training.

a. AirMedCare Memberships: Amy Scott, Membership Sales Manager, gave a brief presentation on the new membership program that is now approved to be offered in Wyoming. She offered to go more in depth with the program at a later time, but if anyone has any questions, they can reach out to her. Commissioner Heath asked if someone is transported from here to somewhere outside of the membership area, is this service covered. Amy replied that the coverage is for any aircraft partner that they are contracted with nationwide, there will be no out of pocket expense for the flight. Jenn Kerr provided a brochure of the coverage areas. Jeanine asked if there was a .pdf version of the brochure that could be sent out with the meeting minutes. Amy stated that she can provide one. A copy will be sent to Beth.

8. LCCCC

Nothing to report.

9. Pine Bluffs/Burns/Albin EMS

Jeanine announced that a new Director of EMS for Pine Bluffs has been appointed, Tony Perry. She is scheduled to meet with him and Allie Leitza over the next month to discuss the Board. Cody reported that Albin EMS has arranged with AMR to get oxygen and make arrangements for their supply.

10. FE Warren AFB/VA

Major Wetzler announced that the first Air Show exercise will be in June. He added that his replacement will be here in July and will bring the new representative to the July meeting.

11. Cheyenne Fire Rescue

Brice Jacobsen reported that the ALTO training went well and that more training will be scheduled soon. They are expecting a go live date of June 1st. Andrew Dykeshorn reported the process for coordinating rehab through IC. They will also be doing RERT familiarization with AMR and conducting a toxicological class for up to 30 Paramedics.

12. County Fire Districts

Matt Butler wanted to thank AMR for their help with the Polo Ranch fire.

13. Information Technology

Dominic Davis reported that there was a significant upgrade completed and announced that if there are any issues, to contact IT for help.

14. Funding Requests

Nothing to report.

15. Old Business

There was no old business to discuss.

16. New Business

- a. Exhibit 2: Jeanine stated that the new exhibit was sent to the Board and asked if there were any comments. Chief Kopper moved to approve Exhibit 2. Josh VanVlack seconded. Jon stated that there were very few changes, just adjustments to allow more room in the units for the LUCAS devices. All voted in favor of the update.
- b. EMS Contract Wording: Jeanine reviewed that under 11.3.3.c Exemption Requests, it was researched and there was a misprint. The "Except for Priority 1 and 2 call" should have been added to 11.3.3.e 100 Call Transport Rule. The solution to move the wording to the intended place in the contract would need to be discussed and an addendum to the contract approved by the Board. The addendum would be reviewed by the County Attorney and AMR. After that, the Board would need to move to approve the addendum at the next meeting for final signatures. Jeanine also made note that the example section under 11.3.3.e where it uses Priority 1 and 2 calls, would need to be

changed to Priority 4 and 5 since they would not be considered under this section. The suggested wording was provided to the Board by Beth and Jeanine which would read:

- e) One Hundred Transport Rule
 - 1. For the purposes of determining compliance with response time requirements within the service area each month, the following method will be used except for Priority 1 and Priority 2 calls:
 - 2. For example, if a geographical category produces 105 Priority 5 transports and 89 Priority 4 transports during a single month, the CONTRACTOR will be required to meet 90% compliance for the month for Priority 5, while Priority 4 will be subject to the 100 Transport Rule.

Byron Mathews moved to amend section 11.3.3.c by removing "Except for Priority 1 and 2 calls" and inserting the wording into 11.3.3.e and defer the example language to be submitted with the amendment to reflect the correct change. Chief Kopper seconded the motion. Byron stated that the wording was simply being corrected to the intended section. All voted to approve.

The meeting was adjourned at 2:24pm.
