

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and began at 1:30pm. Byron Mathews began the meeting by welcoming everyone.

#### 1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Byron asked if there were any requests for changes or corrections to the minutes. Jeanine West made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

#### 2. Finances

Carrie Deselms reported that there was nothing out of the ordinary for expenses this month.

a. Final RFP Expenses Breakdown: Beth reviewed the last meeting's discussion on the final breakdown of expenses for the RFP contract with Health Care Visions. She presented the breakdown for each organization's contribution. It was determined that each organization would receive a reimbursement of \$2,424.90. Jeanine recommended

- that a letter be sent along with each of the reimbursement checks explaining the reason for the reimbursement. Beth stated that she will compose a letter.
- b. Proposed Budget & Annual Meeting: Beth brought to the Board that the annual budget deadlines are approaching. The proposed budget is due by the end of the month and the final budget is due in July. She presented the proposed budget to the group and what will be sent to the newspaper for the Public Notice which is required for the June meeting. Beth added that nothing has changed except for the removal of the contract services line. The June meeting will be where the Board will vote on the budget and the regular meeting will follow.

Tracy Garcia moved to approve the proposed budget and the finance reports as presented. Jeanine West seconded the motion. All Board members voted in favor.

#### 4. Monthly Reports

- a. Narva & Associates: Jon Narva reported that AMR was fully compliant in all areas for the month. He reviewed the number of calls for service, the exemptions requested, and the compliance in the various zones. Jon reported that a Variance report was received which did not necessarily fit into what the report was meant for, however it did identify some action items for all of the agencies involved. He was pleased to report that the EMS map layer had gone live at the beginning of the month and AMR has not experienced any issues. They will be sorting through the calls and coding properly for the contract language and next month they will have a better statistical look at the new map layer. Jeanine West asked if the response times had any issues. Cody Schilling replied that overall there were not any issues except for 5 calls within the new zones and these were calls that are usually late anyways due to existing obstacles at those locations. Jon further reported that he has received the certifications from Pine Bluffs this morning which was not reflected in the report he sent out. According to the report. Jon is still missing the certifications from LCFD #6. Jeanine asked at what point do we give notice. Byron commented that certifications should be due immediately and asked Beth Harris to write a letter to send out to LCFD #6. Jon finished his reporting by stating that the delayed responses were down for the month. There were 3 times this month where the system was close to overload status.
- b. AMR: Kassi Moloney reiterated that they were fully for the month. She reviewed the calls for service, there were no weather exemptions, the core schedule including surging where needed, and their staffing status. Kassi reported that MS150 was back in service and 1 ambulance was still out of service. She stated that there was 1 clinical investigation completed. Kassi stated that they are discussing changes with LCCCC of when units are diverted and procedures for air medical requests. She added that they conducted several training classes, provided mutual aid several times over the last month, they continue with their mobile health, and participated in several events.

#### 5. Medical Directors

Dr. Tortorich reported that they were able to attend training at LCFD #8 this past month.

#### 6. CRMC

Tracy Garcia reported that they are in the middle of construction in the Emergency Department and replacing the floor as well. They will phase the areas that are closed and working on the master facility plan which should begin the first part of July.

#### 7. AirLife

Brian Leonard reported that the engine upgraded is still in progress.

#### 8. LifeLine

Jenn Kerr reported that they are working on standbys and were honored to be a part of the welcome home trip for LCFD #2 firefighter.

#### 9. LCCCC

Chuck Trimble reported that EIDS usage is low and consistent. He added that they have phased out the flip cards and protocols for EMD and are now on android tablets in the center. Chuck announced that air service requests will be revised to state that they will take a response request from whatever service the requesting agency wants. There will be a meeting with the County Attorney to discuss issues behind the scenes and he hopes to have this done within the next week. The center will not make any recommendations. Jeanine asked if requested service is not available what will be the next step. Chuck replied that then the agency requests another and if they are unsure who to request, the LCCCC will provide the next available via rotation.

#### 10. Eastern Laramie County

Carrie had nothing to report from Burns but that they had 2 new people attending the AMR class. She added that Albin is still training firefighters. Carrie added that Pine bluffs wants to know since AMR has the contract if they are planning on having support any time soon. Carrie stated that she had replied that they will talk about it in the future. Jeanine commented that they will need to revisit this option with the Eastern Laramie County group to review what they want to do with the study that was done. It was mentioned that there is a new mayor for Pine Bluffs that needs to be briefed. Dr. Tortorich requested that Dr. Schmitz be invited as well. Kassi asked about the status of the Albin ambulance. Carrie replied that the town will wait until December to make a decision but the fire department is trying to cover the responses.

#### 13. Cheyenne Fire Rescue

Interim Chief Kopper reported that they are finishing their budget to present to the city. Brice Jacobsen reported that case reviews went well with a good turnout. He added that the new LUCAS devices have had 12 deployments within the first month. Brice also reported that they have helped with the Cheyenne-Laramie County Health Department's

vaccinations and they may continue to help now that the 12-16 year olds are approved for the vaccines.

#### 14. County Fire Districts

Nothing to report.

#### 15. County IT

Kate Hoffman had nothing to report and was pleased to hear that the new EMS layer was going well.

No requests had been received.

#### 18. New Business

- a. EMS BBQ: Beth wanted to bring up for discussion the plans for the BBQ and possibly having it in June. She needs to sit down with the Medical Directors and AMR to come up with a date and location for the event. Dr. Tortorich replied that they can meet after the meeting to discuss the plans.
- b. EMS Contract: Jeanine announced that we have received the contract back from the County Attorney but there are still some questions for Jon Narva and Byron Mathews. She added that they need to redo some of the verbiage but they it will be ready to send to AMR. Byron requested that the final draft be circulated among the Board for one last look.
- c. Commemorative 9/11 Ambulance Wraps: Kassi wanted to inform the Board that AMR has designed a new wrap for the ambulances to commemorate 9/11 this year but that it would need to be approved by the Board. Kassi stated that she will compose and email for the Board's review so that a decision could be made.
- d. Variance Report Education: Jeanine wanted to suggest that the group revisit and educate the various agencies on how this report is to be used. She added that perhaps some information on how to report other issues that would not be appropriate for a Variance Report, but that still need to be addressed among the responding agencies. Jeanine made note that the EMS Board does not have any regulatory authority over services such as air but would like to work on bridging the gap between air and ground services.
