

Minutes for Tuesday July 8, 2025

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and via Zoom at the Cheyenne/Laramie County EMA beginning at 1:35pm. Jeanine West began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes for the May and June meetings were sent out prior to the meeting for the Boards' review. Jared Skagen made a motion to accept the minutes. Chief Dykshorn seconded the motion. All board members voted in favor.

2. Finances

Jeanine provided the report with normal expenses and deposits for the months of May and June being made. A payment was made for the protocol app. Jared Skagen made a motion to accept the financial report. Chief Dykshorn seconded the motion. All board members voted in favor.

a. Beth Harris stated that after receiving the final estimate after the annual budget was approved for the Cadaver Lab, the budget would need to be amended to reflect the increase from the original funding request. This is to satisfy the state requirements. A public hearing notice for the budget amendment will be sent.

b. Funding Requests

i. Cadaver Lab: Jeanine reported that a public notice draft needs to be developed and reviewed. The registration for the class will be through Eventbrite. The lab will be at LCCC in their surgical suite and AMR will work on getting surgical supplies with the help of local partners. It was mentioned that some items may need to be reimbursed from EMS JPB funds. Jenn Kerr and CRMC stated that they have expired product that they could donate. Jeanine will send an email with a list of needed supplies to EMS, fire departments and Dr.Berg. The group discussed that registration priority will be to EMS providers. The dates for the lab will be September 9-11 and Jeanine is waiting on LCCC to give their final approval. It was reported that the contracts have been completed with the cadaver supplier. The drop off will be September 8th and pickup on the 11th or 12th. Jeanine stated that registration will be out by the end of the month. Jared Skagen asked where PAs and other ER staff will fit in the priority list. Jeanine replied that she will talk to Dr. Schmitz.

3. Monthly Reports

- a. Narva & Associates: Jon Narva reported everything worked well with 1122 calls for service with an average of 37.4/day for the month. AMR was again fully compliant. There were 28 exemption requests with 27 being approved and 1 denied. Jon noted that AMR had very high compliance in all priorities. Nothing out of the ordinary for the month and there were 4 extended delays.
 - i. Protocol committee: Jon reported that the meeting was canceled for this month due to a lack of a quorum.
- b. AMR: Cody Schilling reported that they had 1122 calls for service and 830 transports with 4.4 units/day staffed on average. He reviewed the delays by hour and noted that there was an increase in call types for strokes due to additional training on overcalling of strokes. It was also reported that there were 4 ROSC and 2 were discharged in good condition. For staffing they were down 2 medics but there are students enrolled in the earn while you learn program. In the meantime the open shifts are being filled by part time medics. Cody reviewed events and preparation for events. He reported that there were 2 investigations completed and they now have 4 paramedic FTOs after 2 promotions. He added that there are classes coming up after CFD and the Fair are over. For partner agencies it was stated that the LCCCC MOU and CRMC MOU is signed. The Drivecam events were listed and the fleet is down 1 unit. There are 2 Type-1s in production and 1 supervisor vehicle. Jon added that here was 1 mechanical breakdown delay

transporting a non-emergent patient so there was a slight delay. Jeanine announced that new doors were purchased by CLCEMA for Echol.

4. Medical Directors

Dr. Schmitz was unable to attend the meeting. Jeanine provided the report. In Albin, the fundraiser was a great success and it was noted that the funds from last year boutght a new Lfie Pack 15. Run reviews and education were discussed in June with the services. There are plans to advance the service level in the future and to continue efforts for recruitment and retention. Dr. Schmitz noted that the service is continually improving and dedicated to serving their constituents. For Pine Bluffs, run reviews were discussed along with education on calculating medicine dosages. They practiced on intubation mannequins for potential RSI and adjuncts. He also noted that they are an outstanding rural volunteer service. Dr. Schmitz noted that Chris Gutierrez with AMR is doing an excellent job taking over for Larry Jones and they have met several times to discuss any clinical care issues. It was reported that case reviews have been reasonably well attended and the protocol committee has nearly finished reviewing and updating the protocols for Laramie County. He also noted that there have not been any significant issues with CFR medics and the care and coordination with AMR has been excellent.

a. Eastern LC EMS (Albin, Pine Bluffs) See Medical Director report.

5. Cheyenne Regional Medical Center

Jared reported that the garage door needs replaced. He announced that work is scheduled to be done on the fire suppression system in the ambulance bay and AMR may see activities going on.

6. LifeLine

Nothing to report.

7. Dispatch:

Amber Young had nothing to report and thanked everyone for allowing them to attend case reviews.

8. FE Warren AFB/VA Medical Center

Dr. Berg announced that the commanders will be switching out. He was asked by Colonel Manning on the plan for the airshow with AMR. Cody replied that they have been a part of the planning and that AMR will be stationed for all of them including the Leapfrogs which require an ALS ambulance on standby. Cody added that they are waiting on a schedule from FEWAFB fire. Jeanine reviewed the CFD/Airshow schedule and the concerns with horses during the parades.

9. Cheyenne Fire Rescue

Chief Dykshorn reported that there were several staffing changes over the summer and they are working on planning for all the events. He announced that Don Wood will be the new CFR representative on the board.

10. County Fire Districts

Josh Vallee reported that LCFD 1 is doing working on staff changing with staff promotions from Engineers to Lieutenants and paid fire fighters to Engineers. He added that they are planning for EMS certification for new hires coming in for EMR and EMT classes.

11. <u>Information Technology</u>

Jeanine relayed from Dominic Davis that if any of the services need updated iPads, Laramie County IT will start replacing the older ones. Cody asked if Pine Bluffs EMS ever received iPads. Matt Butler replied that he was unsure but would followup at the next Fire Chiefs Association meeting.

12. Old Business

a. Board Vacancies: Jeanine announced that several applications were received and 3 individuals were interviewed. The Board held an Executive Meeting to discuss interviews and all of the applicants had beneficial qualities. Jared stated that he agreed. Chief Dykshorn made a motion to appoint Matt Butler to the Board. Jared Skagen seconded. All voted in favor. Jeanine announced that an Executive Meeting will be scheduled next month to discuss roles and responsibilities for the members and future planning. She added that elections for Secretary/Treasurer and Vice Chair will be conducted in August.

13. New Business

The meeting was adjourned at 2:17pm.
