He advised there was one change in the budget for this next fiscal year which was an increase in the Protocol App cost in case the Board voted to upgrade the subscription. Commissioner Heath asked what the meeting expenses funds were used for. Jeanine West provided an example that when there are Executive Meetings, such as during contract negotiations, the Board would provide lunch. Josh Van Vlack made a motion to accept the 2024 budget as written. Jared Skagen seconded the motion. There was no further discussion. All board members voted in favor.

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person at the Cheyenne/Laramie County EMA beginning at 1:34pm after the Annual Budget Meeting. Jeanine West began the meeting by welcoming everyone.

1. Protocol App Presentation

Jeanine introduced Ben Powers from the ACID Remap company who oversees the Protocol App for Laramie County. She added that his presentation will be over the upgrade of the current app to include the hyperlinking which was a change presented to the Board recently to allow the app to be functional. Ben provided a demonstration of the new features and how the system works to update the protocols. Ben stated that the company would train the approved user admins on how to make changes. There was discussion amongst the group concerning the administration access and who would oversee the changes. It was restated that the initial setup cost for the hyperlinking was a one-time setup fee of \$1500 and the annual subscription would be \$4000. The current subscription is at the end of its year which is renewed in July. The subscription would continue to be paid out of the reserve funds. The group discussed the access of users and future maintenance of the protocol features. Chief Kopper made a motion to approve funding for the upgrade of the Protocol app to include a one time fee for the hyperlinking. Josh Van Vlack seconded the motion. All Board members voted in favor.

Jeanine stated that she would provide the information to the Protocol Committee prior to their meeting in July.

2. <u>Previous Meeting Minutes</u>

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Chief Kopper made a motion to accept the minutes. Titus Norris seconded the motion. All board members voted in favor.

3. Finances

Chief Kopper provided the report with normal expenses for the month being made. He reported that no funding requests were received. Beth Harris noted that the public notice bill had been received and payment would be submitted after the meeting. Titus Norris made a motion to accept the financial report. Josh Van Vlack seconded the motion. All board members voted in favor.

4. Monthly Reports

- a. Narva & Associates: Jon Narva provided his report that the system was stable for the month, but that calls were up with 1068 calls for service which averaged to 34 ½ calls per day. He noted that there were fluctuations between the days that were unusual. There were 81 exemption requests and all were approved. After review of the data, Priority 5 calls showed an increase in calls which were back up to a normal level. The total unit hours for the month were standard and transports accounted for ¾ of the total calls. There were 5 extended delays, 4 Priority 1 and 1 Priority 2. The Priority 1s did not hit their times due to overload, but the times were 21-23 minutes which meant that there were not extreme wait times for the patients.
- b. AMR: Kassi Moloney provided her report to the group. She commented that their calls increased by 111 calls for May. She stated that she will continue to include the hourly breakdown in her report. There were 6 mutual aid responses for the month. The new shift schedule began May 15th and reviewed the staffing for AMR which is improving. She continued with her report listing the special events and training. There was 1 clinical investigation completed for the month. Kassi reported that there were 250 transport reviews and no RSIs were performed. Kassi announced that AMR is now a part of the Wyoming Healthcare Information Exchange. Larry Jones and Kassi noted that patients do have an opt-out option, but this system allows patient information to be shared with other partner hospitals. Kassi reviewed the partnering agency reports and reviewed the AMR activities for EMS Week. She added that they will be conducting quarterly case reviews with the Laramie County Fire Authority. Kassi noted that the DriveCam numbers were at 21. Kassi noted that they are still working on the SOP reviews and the Exhibit 2 has been completed.

5. Medical Directors

Dr. Gary Schmitz provided his report. He stated that Brice Jacobsen provided a presentation on seizures at the morning case reviews. Dr. Schmitz noted that he met with Larry to discuss minor issues with regards to patient care and they have been resolved. He reported that Jon, Brice, Larry and him met after case reviews that morning to discuss an idea that Jon had about using the OWL system to monitor certifications. Jon has reached out to Scott Logan at the state about using the system to monitor personnel certifications. This allows a continual process throughout the year to monitor certifications instead of once a year. Dr. Schmitz continued with his report that Albin EMS has moved into their new building at the Community Center. He will be working on more education opportunities and aeromedical services for Albin. He added that Pine Bluffs EMS completed education and are doing an outstanding job. Tony Perry announced that they started the AEMT class with 9 students. He is also working on recruiting new residents in Pine Bluffs that are Paramedics.

6. CRMC

Nothing to report.

7. <u>LifeLine</u>

Nothing to report.

8. Dispatch

Amber Young reported that there were 2 new people hired. There were 12889 calls for service and 1254 of those calls were for EMS.

9. Eastern LC EMS

See Medical Director report. Jeanine announced that with the WYOLink funding Albin EMS will be receiving a radio.

10. FE Warren AFB/VA Medical Center

Dr. Gantz reported that there were changes to the gate hours. He stated that Gate 1 will be 0600-0800 and 1600-1800. Gate 2 will be 0600-1800 and Gate 5 is 24/7 access. He announced that they will be conducting their Mass Casualty exercise in July. Jon asked if the gate changes were in place for a while. Dr. Gantz stated that they are.

11. Cheyenne Fire Rescue

Chief Kopper reported that there are 10 recruits starting and the new stations are moving along.

12. County Fire Districts

Nothing to report.

13. Information Technology

Dominic Davis announced that Kate Hoffman will be leaving July 3^{rd} and Jeff Kling will be leaving as well.

14. Old Business

a. Freshman Impact Program: Josh reported that they are currently looking for a new director and are not taking on new projects at this time. He will look at future dates once they are able to start scheduling.

15. New Business

- a. Jon reported that he did receive the proposed update to Exhibit 2 for review and will present it to the Board after Dr. Schmitz and him have taken a look. Jeanine asked if after the review, the Exhibit 2 could be emailed to the Board prior to the next meeting.
- b. Jeanine announced that she would not be available for the July meeting and asked the Board if there would be enough attendance to hold the meeting in July. It was decided that Josh will head the meeting in July.

The meeting was adjourned at 2:36pm.
