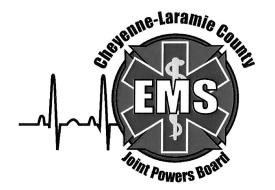

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person beginning at 1:32pm. Jeanine West began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Jeanine asked if there were any requests for changes or corrections to the minutes. Byron Mathews made a motion to accept the minutes as written. Chief Kopper seconded the motion. All board members voted in favor.

2. Finances

Chief Kopper reported that the payments were typical for the month and reviewed the totals for the account which included the expenditure for the Public Notice for the annual meeting. Byron Mathews motioned to approve the financial report. Josh Van Vlack seconded the motion; all board members voted in favor.

3. Monthly Reports

- a. Narva & Associates: Jon Narva reported that overall it was a normal month and AMR was compliant in all priorities. This last month the calls were down with the same distribution call. Jon informed the group that the final graphic for Exhibit 7 has not been completed however the LCCCC dispatching is using the correct layer for dispatching units. The only item we are waiting on is the removal of the Burns EMS jurisdiction from the printed graphic. Jeanine asked if the delay was due to the GIS office being short staffed. Jon responded that it was his understanding that they were and the office was working towards the completion of the printed graphic. Jon reported that there were 11 late calls in the Priority 5 transfers which were put on hold for emergent calls. AMR was still compliant in this area and are noted in the log provided in the monthly report.
- b. AMR: Kassi Moloney reported that their call volume was slightly down. There were a total of 6 mutual aid requests. She added that the deployment schedule has not changed. There will be a change in the Captains' schedules in June from 24 hour shifts to 12 hour shifts. Kassi stated that they have added a fourth Captain, Jillian McLaughlin, to help staff the schedule. She continued to review the structure of the new schedule. As for staffing, Kassi reported that they are short on EMTs, but are fully staffed on Paramedics. They are using summer help to fill in for the EMT positions. She reviewed the special events schedule for the month and in the future. Kassi went through the partnering agencies and their projects together. She noted that the ALTO MOU has been sent to legal at CRMC and are awaiting their response. She also informed the group that they have moved their post from Blue FCU on Pershing and are now posting at the VA. Kassi stated that there were no clinical investigations and several chart reviews were completed. There were also several trainings that AMR participated in. Kassi added that there were 14 total DriveCam triggers. Causes were speeding due to 2 of the units not able to be governed, braking, and a blocked camera. Kassi stated that there was a side swipe, during an emergent call, with a private vehicle that resulted in minimal damage to both vehicles. This incident did not cause a trigger with the DriveCam and a Captain responded to the scene after the other driver made contact with dispatch to report the accident. After the call was completed, the unit returned to the scene and no one was cited for the accident. Kassi reported that they have not heard anything recently about their CAAS application. As for the therapy dog program, they have received 2 applications and hope to move forward with starting the program.

4. Medical Directors

Dr. Schmitz reported that Albin is doing well and have 2 new recruits. He added that Pine Bluffs has a new EMS Supervisor, Tony Perry. Jeanine announced that she does have a meeting with him on Friday to discuss the EMS Joint Powers Board. She added that they have had some good discussions on the operations of Pine Bluffs EMS and answered quite a few of his questions. Dr. Schmitz talked briefly about the new ALTO program and the benefits of this program. He added that case reviews went well.

5. CRMC

Jared Skagen reported that there is construction starting at the East campus starting in September and therefore ambulances will need to use the main entrance.

6. <u>LifeLine</u>

Nothing to report.

7. LCCCC

Amber Young reported that due to staffing challenges, they will be switching back to 12 hour shifts July 1st. On the day of the meeting LCCCC staff were participating in Active Shooter training. She announced that she will be conducting her Line of Duty Deaths presentation for the APCO conference if anyone is interested.

8. Pine Bluffs/Burns/Albin EMS

See meeting minutes under Medical Directors.

9. FE Warren AFB/VA

Major Wetzler wanted to say thank you to AMR for their quick response in regards to a staff member having a heart attack. He had a question on the dispatch of calls, when a staff member called into dispatch they were informed that the address did not exist and therefore were unable to respond. Byron Mathews provided an explanation that the FE Warren and Guard base were asked to assist in working with the GIS office to resolve the address issue, but that it was stalled in the higher offices of the Federal Government. In summary, the conversation needs to begin again and followed through with FE Warren AFB decision makers. Jeanine recommended that the notes from previous meetings be provided to the medical group so that this issue can be resolved with Major Wetzler's successor. He added that he may or may not be present at the July meeting.

10. Cheyenne Fire Rescue

Chief Kopper reported that there were 2 graduates who started. Brice Jacobsen provided an update on the ALTO progress and will send out the new podcasts for everyone.

11. County Fire Districts

Nothing to report.

12. Information Technology

Kate Hoffman reported that they are beginning preparations for CFD and they are finishing the cleanup from the recent update. She added that the issue with the MVAs is still being worked on and requested an updated contact for the company to resolve the reporting issue.

13. Funding Requests

Nothing to report.

14. Old Business

a. EMS Contract Addendum: Jeanine reviewed that an addendum was approved by the Board to address the wording in 11.3.3.c and e. It was signed and returned to the Board. Josh Van Vlack made a motion to approve the addendum as prepared. Chief Kopper seconded the motion. All members voted in favor. Jeanine stated that the contract will be updated and sent to the group.

15. New Business

Nothing to report.

The meeting was adjourned at 2:24pm.
