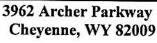

The Cheyenne/Laramie County EMS Joint Powers Board meeting was held in person and began at 1:30pm. Byron Mathews began the meeting by welcoming everyone.

1. Previous Meeting Minutes

Minutes were sent out prior to the meeting for the Boards' review. Byron asked if there were any requests for changes or corrections to the minutes. Chief Kopper made a motion to accept the minutes as written. Jeanine West seconded the motion. All board members voted in favor.

2. Finances

Carrie Deselms reported that there was nothing new for expenses this month outside of regular expenses. Beth Harris reported on the end of year budget which was normal and overall the we were under budget. She reviewed the final reports with the group. Carrie asked if the electronic transfers were working. Beth stated that they are working great. Beth added that due to the beginning of the fiscal year, there was nothing to report. Jeanine motioned to approve the budget report; Chief Kopper seconded the motion; all board members voted in favor.

a. Annual Budget Submittal – Beth reported to the group that the budget was submitted and approved by the state and county.

Carrie motioned to approve the finance and budget report; Jeanine West seconded the motion; all board members voted in favor.

3. Monthly Reports

- a. Narva & Associates: Jon Narva went over his monthly report. He advised AMR was fully compliant in all areas for the month. There were 1145 calls for the month which were up considerably. There were 44 exemptions, with 5 denied. Jon reviewed the geographic distribution of calls and noted that 96% of the calls were shown as in the He added that the new map layer appears to be working. Recommendations included a Variance Report that involved a burn incident. Jon reported that he had just received it and has started in on discussions but does not have all of the information at this time. Jeanine commented that she had received an email from Tracy Garcia concerning the incident which appeared that the call involved diverting the patient to the burn center in Greeley. Dr. Tortorich reviewed the situation that there was concern about the decision being made by responding crews and not the ED. She explained that later they were informed that Dr. Waters was contacted about the decision. Dr. Schmitz stated that after conversations with Dr. Waters and others involved that there needs to be more research into the situation. He added that there was no harm to the patient but other issues might be able to be addressed after researching further into the report. Jeanine recommended that followup reports be provided by AMR and Dr. Waters. Jenn Kerr added that the dispatch call for the helicopter may have been recorded and they could provide this to the board for the Variance Report. The group continued to discuss the report, the situation and next steps for Jon to take for investigating the report. The report findings will be reviewed at the next meeting and if needed recommendations will be provided.
- b. AMR: Kassi Moloney reiterated that they were fully compliant for the month and went over AMR's monthly report. She stated that they are fully staffed and are still looking for part-time EMTs and Paramedics. They did participate in the MCI drill on the base over the past month.

4. Medical Directors

Dr. Schmitz stated that he met with Burns EMS and they are doing a good job. Dr. Tortorich reported that they will be having a meeting with CRMC to discuss limiting the narcotics being used. She added that case reviews were conducted and went very well.

5. CRMC

Tracy Garcia was unable to attend but Byron Mathews stated that she had nothing to report.

6. LifeLine

Jenn Kerr reported that they have had a busy month and will be at CFD to participate in a joint booth.

7. LCCCC

Amber Young stated that they are busy hiring to fill 9 empty positions. She added that they are working on updating some of their policies and procedures.

8. Eastern Laramie County

Carrie had nothing to report for Burns or Pine Bluffs EMS. Carrie informed the group that Albin has been experiencing changes to include going to a Fire Rescue. The Town of Albin had reviewed the needs assessment and there is a person in the community that is working on rebuilding the ambulance service for Albin. The Town Council had decided to reorganize the board and has appointed a new Director, Allison Anderson. Carrie wanted to bring up for discussion with the Board her continuing to represent Eastern Laramie County. Byron had no issue with allowing Carrie to remain on the Board for the rest of her term and in the meantime look at filling the vacant position. Jeanine stated that she would review the By-Laws to determine what is needed for the Eastern Laramie County representative. Carrie agreed to remain on the Board until the end of the term.

9. FE Warren AFB

Maj Wetzler wanted to say thank you to everyone that participated in the recent exercise, Operation Ready Eagle.

10. VA

Beth Harris reported on behalf of Dutch McBride. He stated in an email that they had seen an increase in COVID for their catchment area that runs from Greeley to Casper and Rawlins to Sidney. There have been many large events recently in these areas and COVID has been spreading.

11. Cheyenne Fire Rescue

Brice Jacobsen reported that this month was busy. He reiterated that there have been a lot of calls. He added that several people, including AMR and CFR, have met to participate in the ALTO project which has been going on in Colorado. They have been trying it at the hospital and have started looking at expanding it to the EMS. Brice added that this project will be a published project. Brice also reported that the Protocol Committee meeting was today and case reviews went well.

12. County Fire Districts

Nothing to report.

13. County IT

Kate had nothing new to report.

14. Funding Requests

No requests had been received.

15. Old Business

a. June BBQ: Byron stated that the BBQ went well. Dr. Tortorich suggested that this be an annual gathering put on during EMS week.

b. Live Healthcare: Larry Johnson brought up for discussion that there have been some discussions with a group that expressed interest in providing services. Jeanine commented that at the last meeting, there was discussion on forming a committee to organize this service so that the resource could be spread amongst various groups. Larry stated that their compliance department check with the Board to ensure that they can move forward with this project. Discussion continued among the group about the various situations and what resources are able to be provided. Jeanine commented that this was discussed with Mark Voss and he was in favor of this type of group and interested in helping. She added that this would be outside of the Board's purview but would be interested in assisting with developing the resources within the community and arrange meetings.

16. New Business

a. System Improvement Recommendation Form: Jeanine recapped that Jon had suggested that a system recommendation form be developed to address issues that are not necessarily patient care related. Jon reported that he had designed a form that gathers the basic information such as the incident type and what can be done to improve the system. Jon would facilitate the conversation and anyone could fill out the form. Jeanine added that an email would be sent out describing the difference between the Variance Report and the System Improvement Recommendation Form. In the email, it will also explain that the Variance Reports are to be sent in to Jon Narva and the System Improvement forms would be sent to Beth Harris. Jon will work on streamlining the forms.

The meeting was adjourned at 2:14pm.
