#### Submit Application meeting all the following requirements. An incomplete submittal is not accepted.

- > Application with pre-application meeting notes.
- Land Analysis Map and Preliminary Development Plan. See LCLUR 2-1-100 (iii) through (vii) for requirements and content.
- > Environmental Services Impact Report.
- > Preliminary Drainage Plan and Preliminary Traffic Study.
- Payment of required fees at time of submittal. Digital copy of all files.

The applicant posts property at least 30 days prior to public hearing. Provides proof of posting. Planning notifies adjacent property owners by certified mail at least 30 days prior to public hearing. Planning publishes public notice in newspaper at least 30 days prior to public hearing.
