## 2022 LCSO Goals

**A One of our goals for 2022 was to reduce vehicle theft by 25% by increasing patrols in areas prone to having vehicles stolen. In 2021 we had 111 vehicle thefts. In 2022 we had 75.**

**Another goal was to increase DUI enforcement by 20%. In 2021 we had 93 DUI arrests. In 2022 we had 94.**

**We also set a goal to increase LEAD referrals by 50%. In 2021 we made 43 referrals. In 2022 62 referrals were made by the Laramie County Sheriff's Office.**

**\*\*L.E.A.D. stands for LAW ENFORCEMENT ASSISTED DIVERSION and is a program that diverts misdemeanor non-violent offenders out of the criminal justice system for assistance with underlying mental health or substance abuse problems.**



## Other Department Priorities

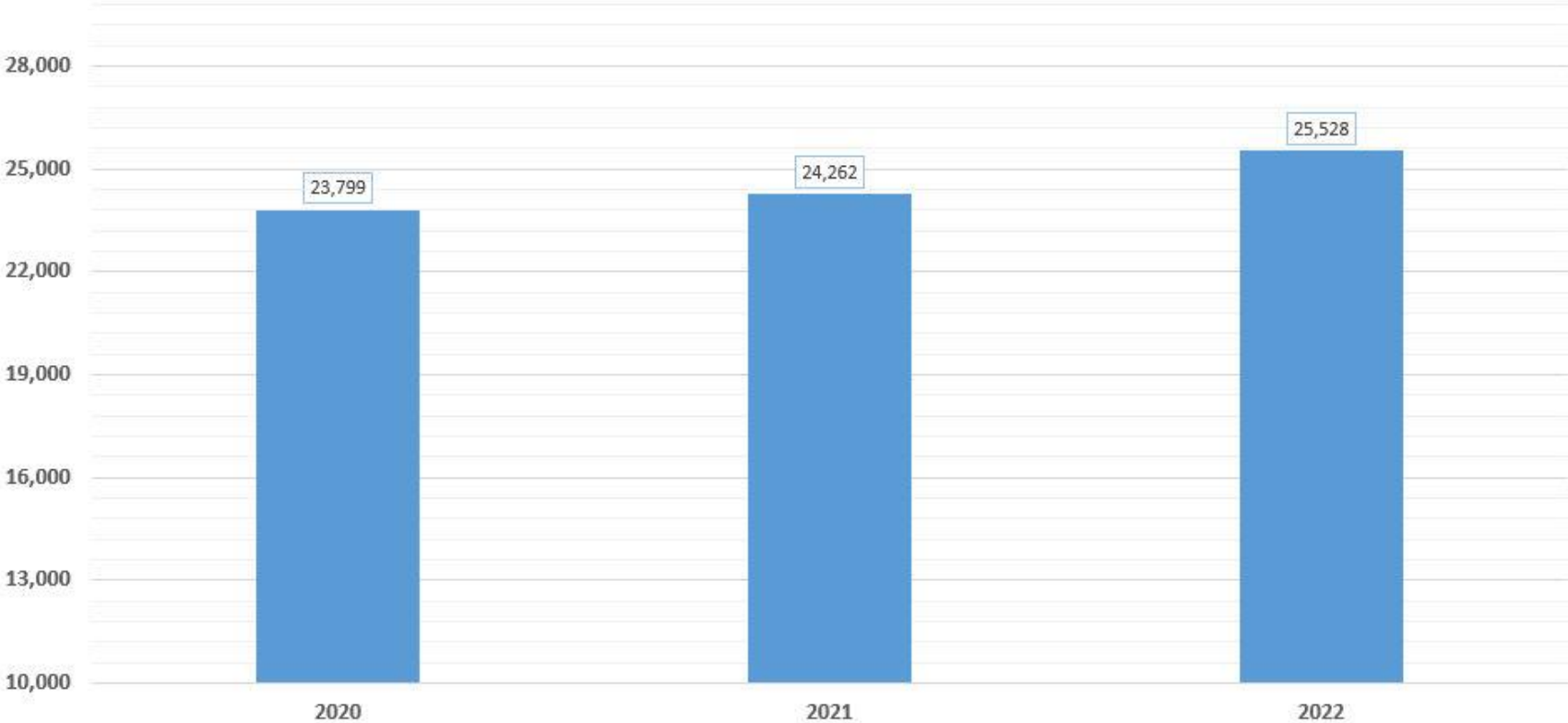
Increased training and focus on responding to people in crisis. We are partnering with Cheyenne Regional Medical Center on a mental health co-response program that will have mental health professionals riding with deputies on patrol to assist with people experiencing a mental health crisis.

Constantly striving to improve both citizen and employee overall satisfaction.

Increasing mental health services in our detention facility

Working with our County Commissioners and Human Resources department to secure pay raises for all county employees.

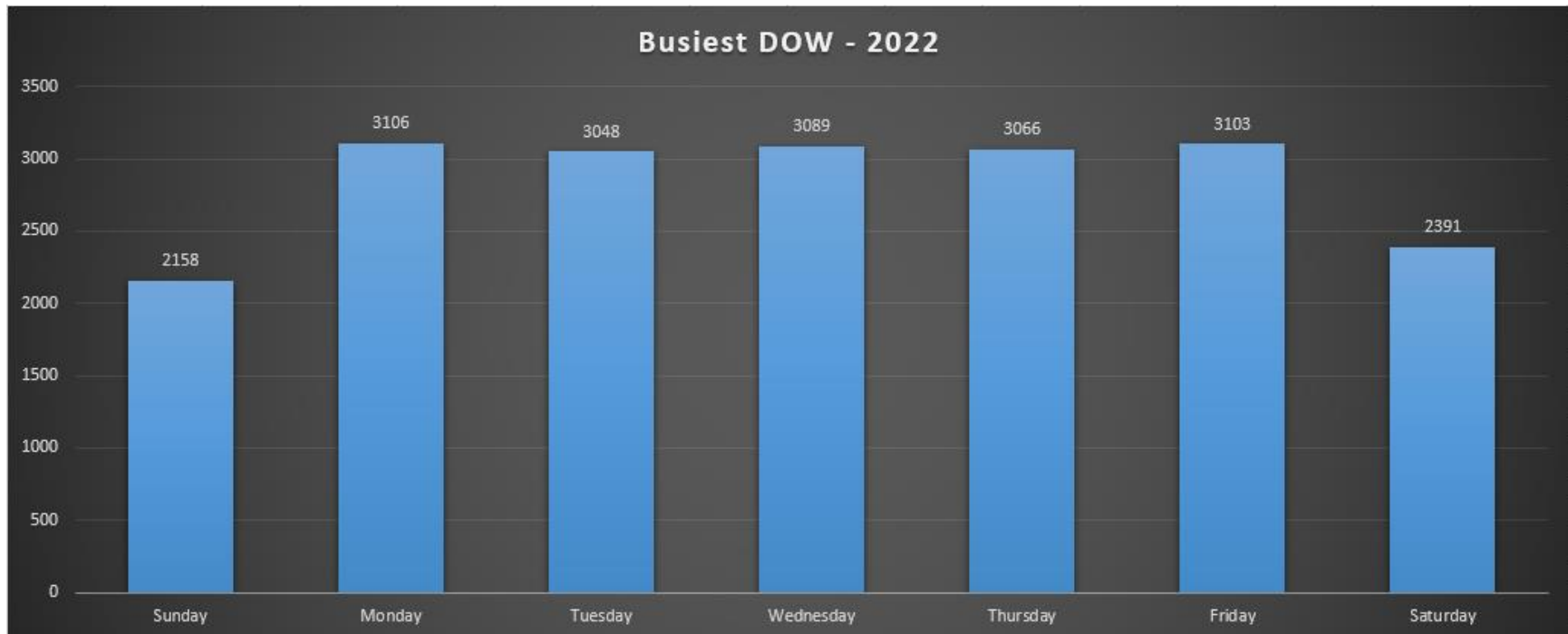
# Calls for Service



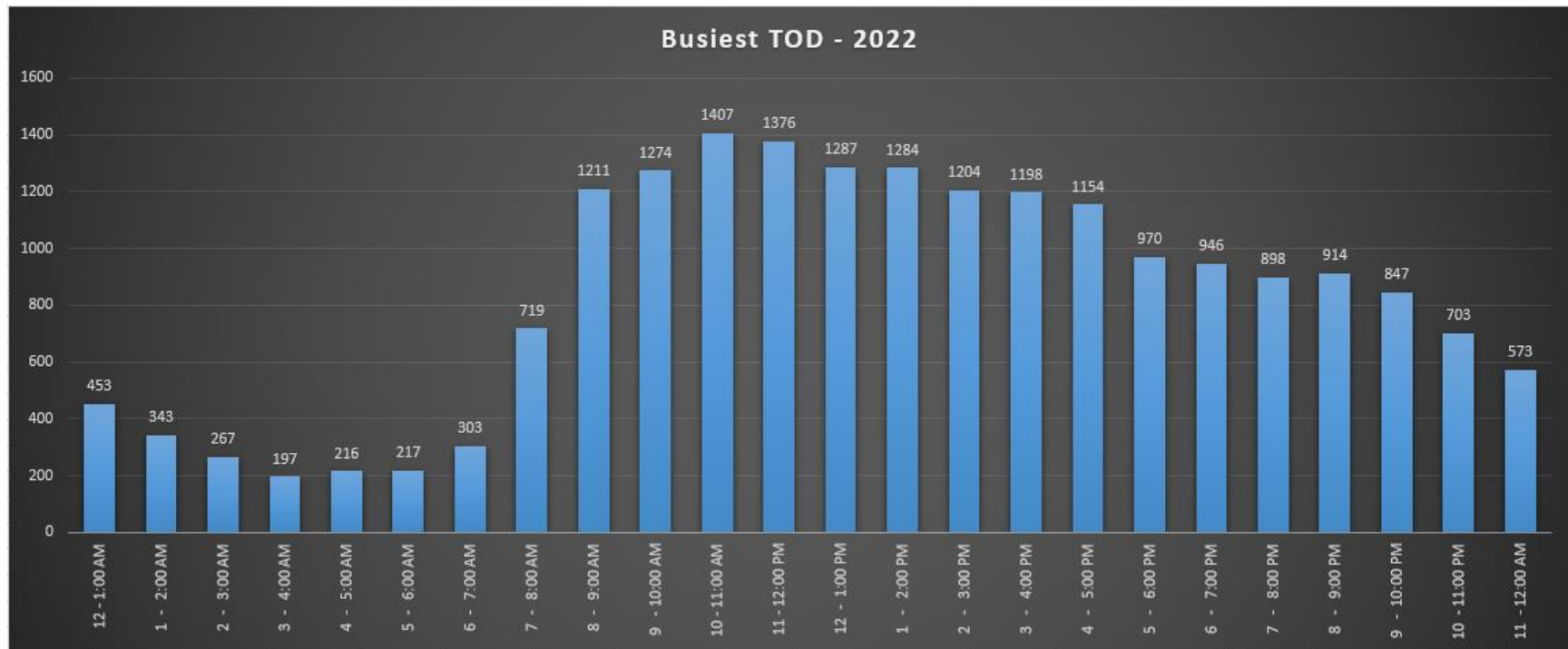
**Total calls for service show a steady demand for law enforcement services in Laramie County.**

# Total calls for service by day of the week



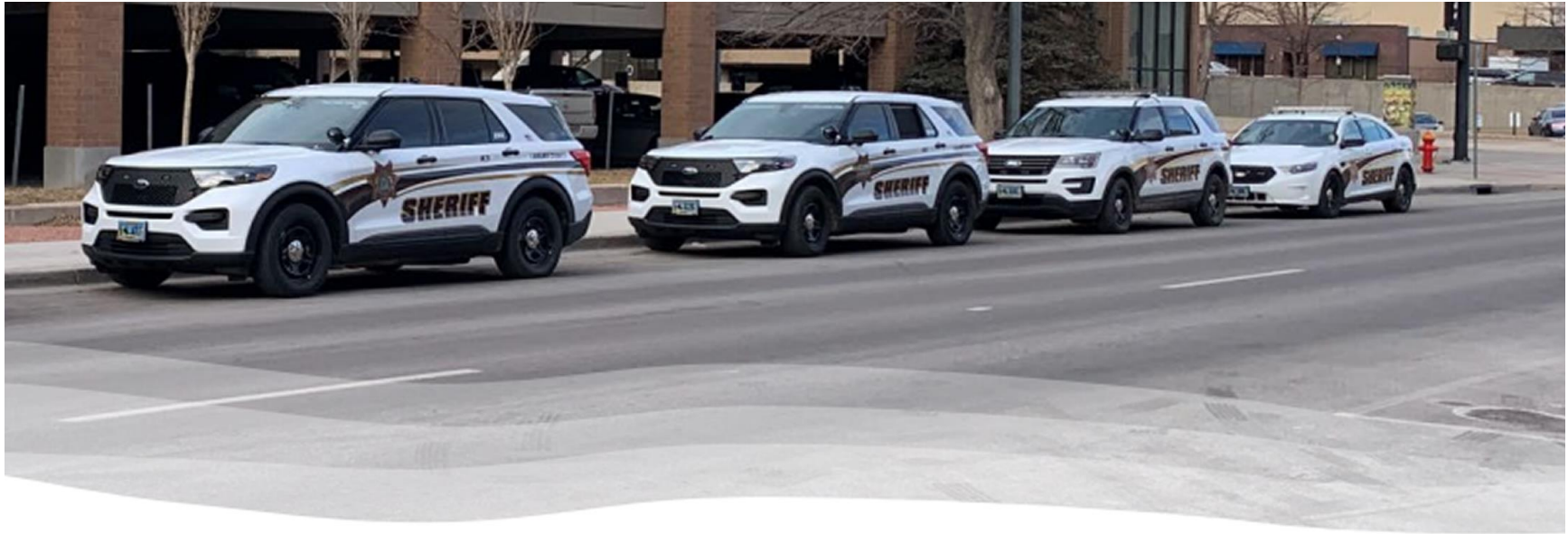
# Total calls for service by time of day

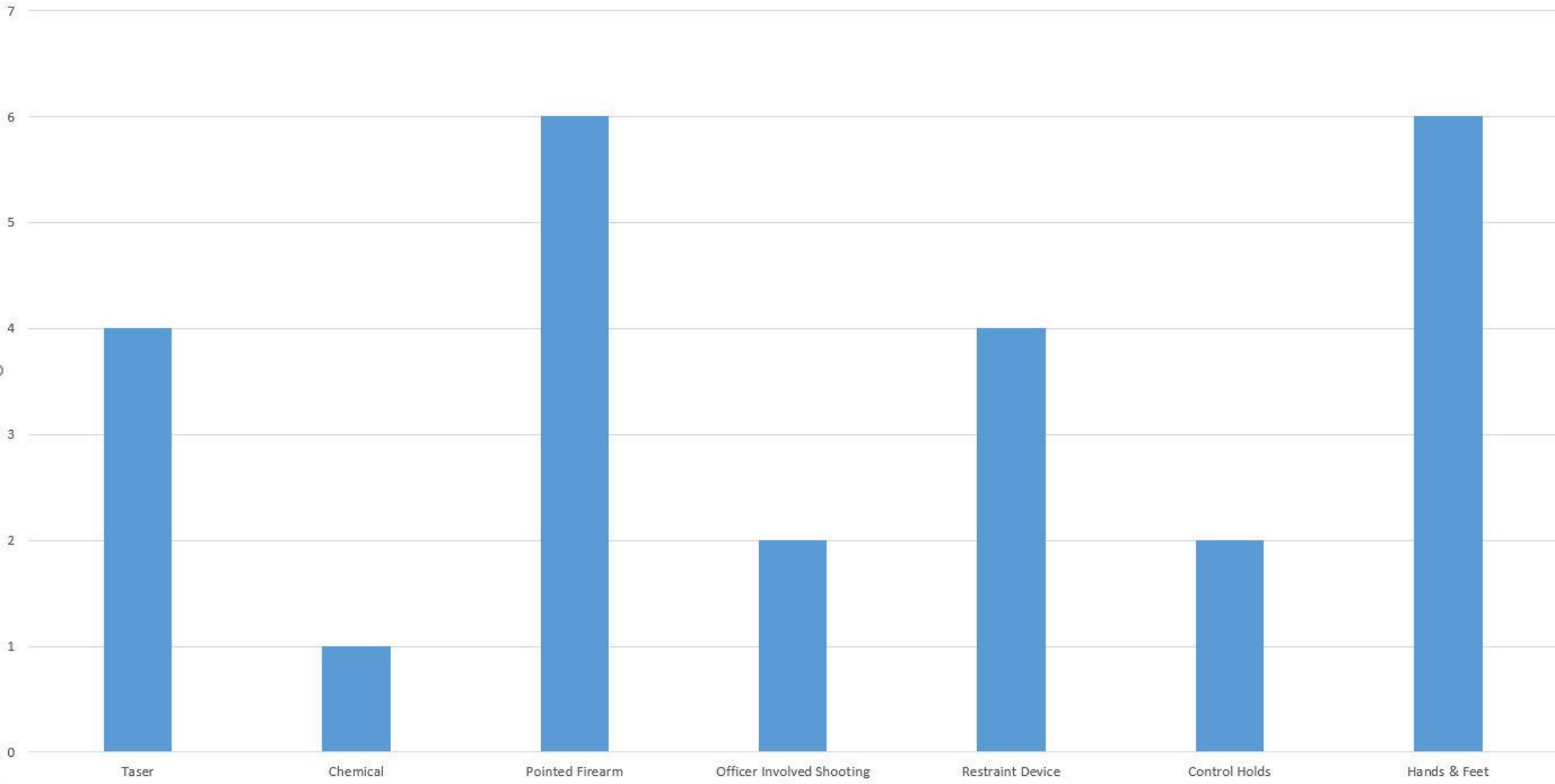

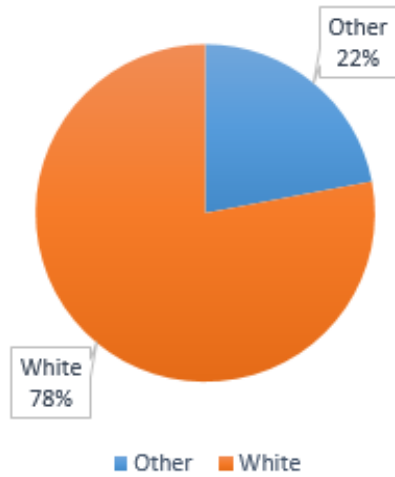

### 2022 Use of Force - Patrol Operations

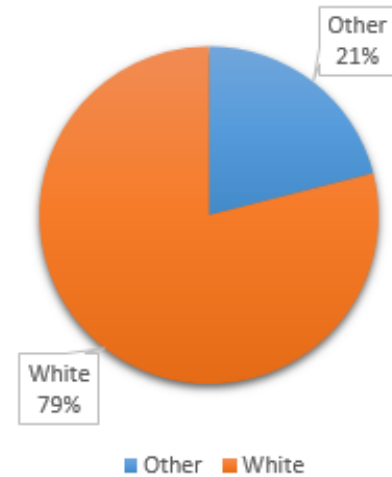


## 2022 Use of Force- Patrol Community Demographics and Transparency

### 2022 Demographics- Laramie County, Wy

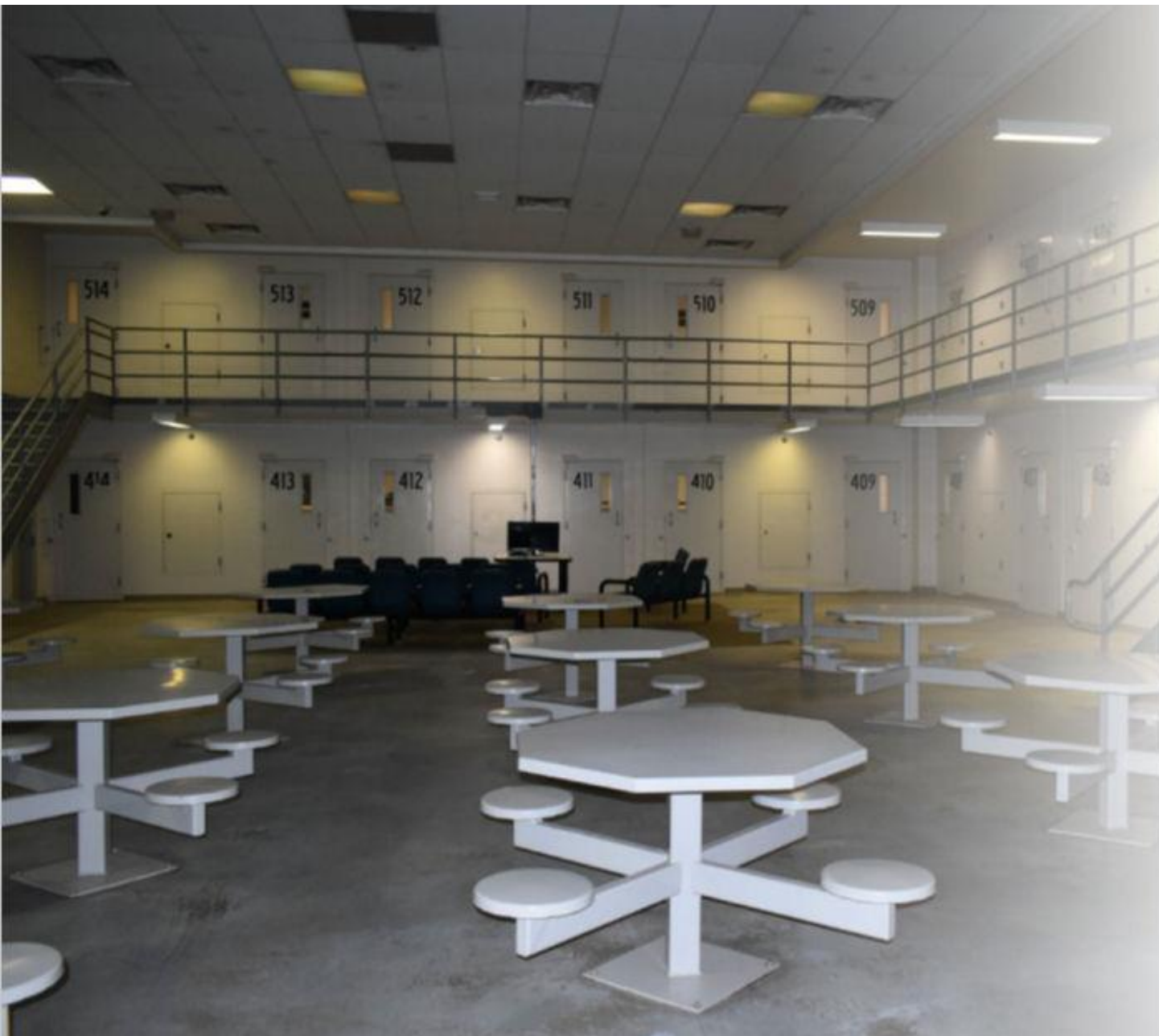


### LCSO Use Of Force-Patrol By Race

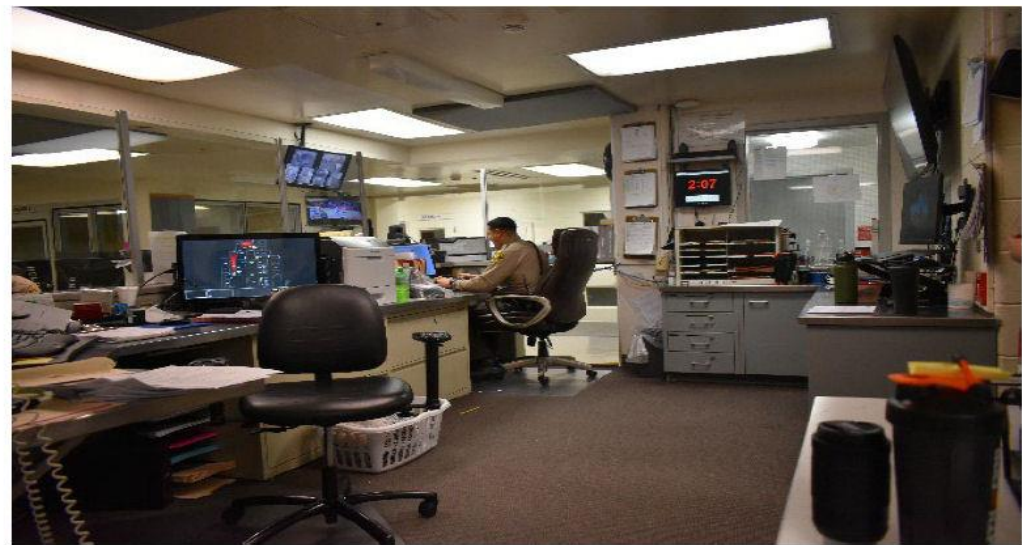
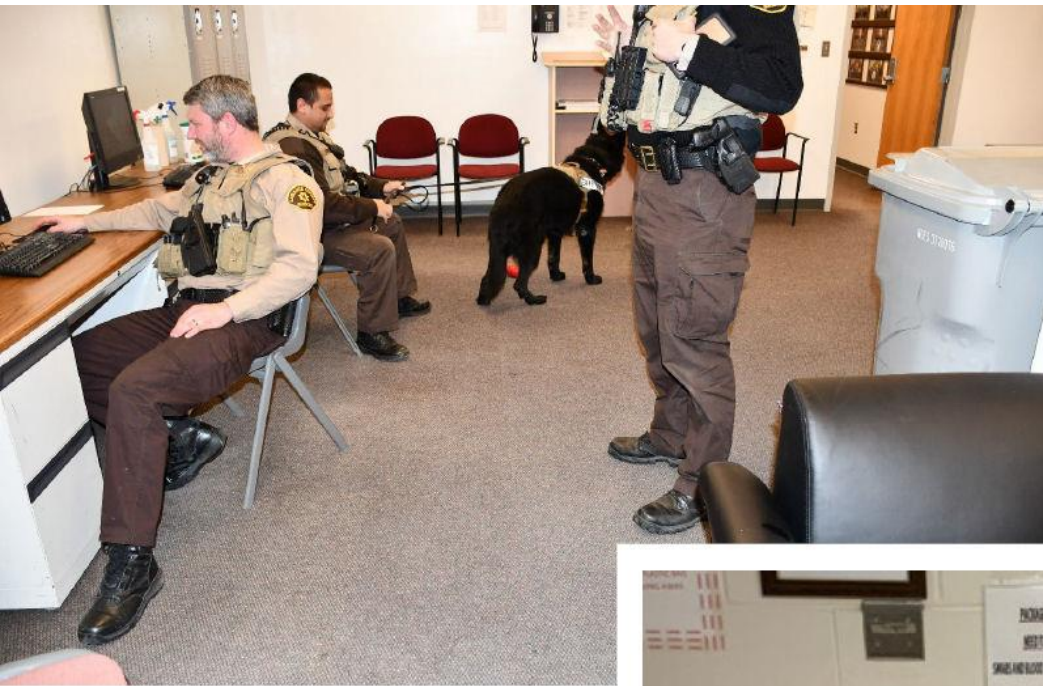
